Housing Assistance

Maine Eviction Prevention Program
(888) 664- 2569

If you rent your primary home in Maine and are behind in your rent or facing eviction, you may be eligible for assistance from the Maine Eviction Prevention Program.

Home Modifications for Aging (Elderly Hardship Grant)
(207) 626-4602

The Maine State Housing Authority offers the Maine Housing's Home Accessibility and Repair Program and a sub-program relevant to seniors called the Elderly Hardship Grant.

The Housing Choice Voucher Program

The program provides rental assistance to income-eligible tenants by subsidizing a portion of their monthly rent and utilities and paying it directly to their landlords.

The Lamb House

The Lamb House is a secure and comfortable single-family dwelling intended to accommodate entire families that have been forced to leave their homes by fire or natural disaster. The Lamb House serves Southwestern Washington County and Eastern Hancock County, Maine.

Safe Harbor – Women/Children Recovery Residence

A place for women to live and grow with their children while seeking recovery from substance use disorder. Our mission is to provide a safe, supportive, affordable living environment for women in recovery.

STEP Program

STEP is designed to provide short term rental assistance to rapidly re-house individuals and families who meet the federal definition of homelessness. STEP is administered directly through the shelters participating in the ESHAP program. The STEP Program is currently offered in ten counties.

Next Step DV Proj.Transitional Housing
